ORDINANCE NO. 11-18

AN ORDINANCE APPOINTING A MUNICIPAL INSPECTOR

WHEREAS, the Taylorsville City Council (the "Council") met in regular meeting on October 19, 2011, to consider, among other things, appointing a municipal inspector; and

WHEREAS, Utah Code Ann. § 10-11-1, *et seq.*, provides in part that the city council may appoint a municipal inspector to examine and investigate real properties located within the City for the growth and spread of injurious and noxious weeds, garbage and refuse, public nuisance, and illegal objects and structures; and

WHEREAS, in Ordinance No. 11-13, the Council adopted an ordinance to implement the provisions of Utah Code Ann. § 10-11-1, *et seq.*

NOW, THEREFORE, BE IT ORDAINED by the Council that the code enforcement officers (who are currently Mickey Pahl and Scott McMahon) be appointed municipal inspectors for purposes of Utah Code Ann. § 10-11-1, *et seq.*, and Taylorsville Code of Ordinances Chapter 9.10.

This Ordinance, assigned Ordinance No. 11-18, shall take effect as soon as it shall be published or posted as required by law, deposited and recorded in the office of the City Recorder, and accepted as required herein.
