**A RESOLUTION ACCEPTING A GRANT FROM THE WAL-MART FOUNDATION
AND FACILITY IN THE AMOUNT OF \$450.00 FOR THE LOCAL FACILITY GIVING
PROGRAM**

WHEREAS, the Taylorsville City Council (the "*Council*") met in regular session on October 15, 2014, to consider, among other things, accepting a City Youth Council grant from the Wal-Mart Foundation and Facility in the amount of \$450.00 for activities associated with the Taylorsville Youth Council; and

WHEREAS, the City has received notice from the Wal-Mart Foundation and Facility that the above referenced grant has been awarded to the City of Taylorsville; and

WHEREAS, Taylorsville Code of Ordinances 2.32.180 provides, among other things, that any grant that anticipates or proposes to bind the City to a particular project or contract shall be submitted to the council for approval prior to accepting the grant; and

WHEREAS, after careful consideration, the Council has determined that it is in the best interests of the citizens of the City to accept this grant from the Wal-Mart Foundation and Facility.

NOW, THEREFORE, BE IT RESOLVED that the Grant is approved, and the Mayor and Recorder are hereby authorized and directed to execute and deliver the same.

This Resolution, assigned No. 14-27, shall take effect immediately upon passage and acceptance as provided herein.
