**A RESOLUTION OF THE CITY OF TAYLORSVILLE
ACCEPTING A GRANT FROM THE STATE OF UTAH REGION II HOMELAND
SECURITY PROGRAM IN THE AMOUNT OF \$2,707 TO BE USED FOR THE
ACQUISITION OF EMERGENCY MANAGEMENT EQUIPMENT**

WHEREAS, the Taylorsville City Council (the "*Council*") met in regular session on November 5, 2014 to consider, among other things, accepting a grant from the State of Utah Region II Homeland Security Program in the amount of \$2,707; and

WHEREAS, Taylorsville Code of Ordinances 2.32.180 provides, among other things, that any grant that anticipates or proposes to bind the City to a particular project or contract shall be submitted to the council for approval prior to accepting the grant; and

WHEREAS, the grant monies will be used for the purchase of emergency management supplies and equipment; and

WHEREAS, after careful consideration, the Council has determined that it is in the best interests of the health, safety, and welfare of the citizens of the City to accept the Homeland Security Program Grant in the amount of \$2,707.

NOW, THEREFORE, BE IT RESOLVED that the Council accepts the Homeland Security Program Grant in the amount of \$2,707.
