**A RESOLUTION IN SUPPORT OF CHANGING THE NAME OF VALLEY REGIONAL
PARK TO THE “GARY C. SWENSEN REGIONAL PARK”**

WHEREAS, Brent C. Overson, a Taylorsville citizen, made a presentation to the Salt Lake County Council requesting that the Salt Lake County Council rename the Valley Regional park located at 5100 South 2700 West in Taylorsville, Utah, to the “Gary C. Swensen Regional Park”; and

WHEREAS, the considerations for re-naming Valley Regional Park after Gary C. Swensen are based on Mr. Swensen’s extensive involvement with recreation, including his participation in various sports leagues, his service as the acquisition director for the Salt Lake County Recreation Department, his twenty years of service as the superintendent of the county’s recreation department, his role in developing and managing adult and youth sports leagues throughout the county, and his role in constructing and developing several parks and recreation centers that continue to serve the public today and to bring beauty to our neighborhoods; and

WHEREAS, Mr. Swenson also served for sixteen years on the Granite School Board, where he worked closely with Salt Lake County’s recreation board and helped to ensure cooperation between Salt Lake County and the school district; and

WHEREAS, Mr. Swenson’s involvement in recreation, community sports and fitness extended beyond the realms of administration to include coaching youth volleyball in church and county recreation leagues, as well as teaching hundreds of youth the value of competition, sportsmanship, and fair play.

NOW, THEREFORE, BE IT RESOLVED that the Taylorsville City Council (the “Council”) hereby endorses and supports Brent C. Overson’s recommendation to the Salt Lake County Council to change the name of Valley Regional Park to the “Gary C. Swensen Regional Park.”
