**Need not be a Taylorsville resident to enter.** Entries will be accepted at the Taylorsville Senior Center (4743 Plymouth View Drive) from 2 to 6:30 pm both Tuesday and Wednesday, March 15th & 16th, 2016. All entries shall remain in place until after the awards ceremony at 3:30 pm on Saturday, March 19th.

Entries must be picked up Saturday, March 19th after the Awards Ceremony at about 4:30 pm. The artist or authorized representative must sign to release each entry.

- Three (3) entries per person per category are allowed.
- One (1) entry per person per category is eligible for award recognition.
- Anyone may enter artwork- need not be a Taylorsville resident to win.
- No pieces previously entered in our show may be resubmitted for display.
- All Photography, Fine Art, and Digital Art entries **MUST** be framed and equipped with hanging hardware, or will **NOT be accepted**.
- A current, non-returnable photograph of the piece must accompany each entry. The Arts Council reserves the right to photograph any piece submitted without an accompanying photograph.
- Label each piece with one of the information slips from the bottom of this sheet. This information card will be moved to the front of the piece after judging. If the piece is for sale, also include the sale price.
- Our qualified judges will be used as the final authority on awards. The judges and/or the Taylorsville Arts Council reserve the right to change classifications if, in their opinion, the entry is better represented in a different classification. Sub-categories such as "Unique" may include a wide range of work. In that case, if more than two(2) persons submit the same type of entry, a new subcategory will be created and judged separately.

#### ARTWORK DISPLAY AGREEMENT AND RELEASE

THIS ARTWORK DISPLAY AGE	REEMENT	VT (this "Agreement") is entered into this

#### **RECITALS**

**WHEREAS**, the City is proud of its local artists and desires to display the work of local artists in public spaces within the City for the public to enjoy; and

**WHEREAS**, the City has arranged for and provided space to display works of art in the City's offices and council chambers located at 2600 West Taylorsville Boulevard, Taylorsville, Utah (the "City Offices"); and

WHEREAS, Artist owns and is the sole creator of the artwork more particularly described in Exhibit "A," attached hereto and incorporated into this Agreement (the "Artwork"); and

**WHEREAS**, Artist desires to display the Artwork at the City Offices according to the terms and conditions specified in this Agreement.

#### **AGREEMENT**

**NOW, THEREFORE**, in consideration of the promises contained in this Agreement, and other good and valuable consideration, the receipt and legal sufficiency of which is hereby acknowledges, the City and Artist hereby agree as follows:

- 1. Permission; Identification. The City hereby gives Artist permission to display the Artwork at the City Offices as specified in this Agreement. Prior to displaying the Artwork at the City Offices, Artist shall (a) complete the description of the Artwork and attach the description to this Agreement as Exhibit "A." The description shall include (1) the size of the Artwork in inches (canvas size, dimensions of sculptures, etc.); (2) the medium used for the Artwork (i.e., oil painting, watercolor, photograph, sculpture, etc.); (3) subject matter; (4) title; and (5) any other identifying information. Artist shall also provide the City with a recent, clear color photograph of the Artwork which accurately depicts the current condition of the Artwork. Artist shall attach the photograph to this Agreement as Exhibit "B."
- 2. <u>Location</u>. The Artwork shall be displayed at such location(s) within the City Offices that the City may from time to time determine in its sole and absolute discretion. The City shall install the Artwork using hangers designed to reduce theft.
- 3. <u>Display Period</u>. The Artwork shall be displayed for a period of approximately one (1) year or at the conclusion of an annual art show sponsored by the Taylorsville Arts Council (the "Display Period"). The Artist shall have the right to retrieve the Artwork from the City prior to the expiration of the Display Period upon at least five (5) days' prior written notice to the mayor of the City. Artist shall immediately remove the Artwork from the City Offices upon the expiration of the Display Period. If Artist does not remove the Artwork at that time, then the City may cause the Artwork to be removed and, at City's option, stored at Artist's cost. The City shall endeavor to give Artist notice of such storage. If Artist fails to retrieve the Artwork from the City within one (1) month after the Artist is notified of such storage, then the City may, at its option and without further notice to Artist, either (a) sell the Artwork and apply the sale proceeds to the City's general

fund; (b) donate the Artwork to a charity selected by the City; or (c) discard the Artwork.

- 4. <u>Artist Identification; Sales and Advertisements Prohibited</u>. Artist may display on the Artwork a small (business-card size) card identifying Artist as the creator of the Artwork and showing Artist's address and telephone number. The purpose of this Agreement is to display the Artwork only; no sales or advertisement for sales of the Artwork shall be allowed during the Display Period.
- 5. **Early Removal from Display**. Artist gives the City, and the City retains, the full and complete rights to (a) remove any or all of the Artwork from display at any time, or from time to time, with or without cause; and/or (b) refuse to display any item of the Artwork that the City deems in its sole discretion to be objectionable. If the City removes from display any of the Artwork prior to the expiration of the Display Period, then the City shall endeavor to notify Artist of such early removal and, in any event, shall take no actions under Section 3 above until after expiration of the Display Period.
- 6. <u>Indemnity and Release</u>. Artist hereby releases and forever discharges the City from, and will indemnify and defend the City against, any and all claims, liability, damages, costs and expenses, including attorney fees and expenses, arising out of the display, loss, theft, transportation, storage, libel, copyright violation, invasion of privacy or damage to or loss of the Artwork. This release binds Artist with respect to these claims, as well as Artist's heirs, assigns, executors, administrators and legal representatives.
- 7. <u>Insurance</u>. The City shall not provide insurance of any kind for the Artwork. The City urges Artist to obtain his/her own insurance coverage on the Artwork while it is on display at the City Offices.
- 8. <u>General</u>. This Agreement represents the parties' entire agreement. No written or oral agreements made prior to this Agreement are binding upon the parties in any manner. Only written modifications to this Agreement shall be valid and binding. All parties to this Agreement must sign such modifications. Time is the essence of this Agreement.

**IN WITNESS WHEREOF,** the parties have caused this Agreement to be executed as of the Effective Date.
