**1.  9:07 PM Consideration of RDA Board Meeting Minutes of May 1, 2019**

Board Member Brad Christopherson **MOVED** to approve the Minutes from the May 1, 2019 RDA Board Meeting. Board Member Curt Cochran **SECONDED** the motion. Chair Dan Armstrong called for discussion. There being none, he called for a roll call vote. The vote was as follows: Harker-yes, Christopherson-yes, Armstrong-yes, Cochran-yes, and Burgess-yes. All Board Members voted in favor and the motion passed unanimously.

**2.  9:08 PM Public Hearing – To Receive Public Comment on the Final Amendment to the Fiscal Year 2018-2019 Budget for the Redevelopment Agency of Taylorsville City**

Chair Armstrong opened the public hearing and asked if there was anyone who wanted to comment on the 2018-2019 RDA Budget. CFO Scott Harrington clarified that there has been \$75,000 in additional property tax received in revenue this year. This is the only amendment

made to the 2017-2018 RDA budget. There was no public comment and Chair Armstrong closed the public hearing.

Chair Armstrong opened the public hearing to receive comments on the Tentative RDA Budget for Fiscal Year 2019-2020. Mr. Harrington explained that this budget is similar to last year's except that the interest income is increased somewhat and the tax revenue is up from \$280,000 to \$550,000 because the Bennion Point EDA project area has been triggered. This is the site where the Summit Vista development is being built at 6200 South and Bangerter. There were no public comments and Chair Armstrong closed the public hearing.
