**2.36.040 CAMPAIGN FINANCE STATEMENTS:**

A. All candidates for municipal office shall comply with campaign finance disclosure requirements as prescribed in Utah Code Ann. §10-3-208 or its successor.

B. In addition to the requirements set forth in Section 2.26.040(A) above, each elected official and/or candidate for municipal office shall file with the city recorder a campaign finance statement containing the information required in this Section on March 1 of each year.
