



**ELECTED OFFICIALS ANNUAL AND MUNICIPAL CANDIDATE  
CONFLICT OF INTEREST DISCLOSURE STATEMENT**

*Pursuant to UTAH CODE ANN. §§10-3-1313 and 20A-11-1604(6), all elected officials shall disclose the below information no sooner than January 1<sup>st</sup> and no later than January 31<sup>st</sup> of each year during which the elected officer holds office. Within ten business days after receiving an elected officer's written disclosure statement, the City Recorder shall publish the disclosures on the City's website where it shall remain until the elected officer leaves office. It is unlawful for an elected officer to fail to submit or amend a written disclosure statement pursuant to UTAH CODE ANN. §10-3-1313(5). An elected official who violates §10-3-1313(5) is guilty of a class B misdemeanor, and the City Recorder shall report the violation to the Attorney General.*

*UTAH CODE ANN. §20A-11-1602(1) defines a conflict of interest as an action that is taken by a[n elected officer] that the [elected officer] reasonably believes may cause direct financial benefit or detriment to the [elected officer], a member of the [officer's] immediate family, or an individual or entity that the [officer] is required to disclose under the provisions of this section, if that benefit or detriment is distinguishable from the effects of that action on the public or on the [officer's] profession, occupation, or association generally.*
